



# ALENZA Peel

### GENERAL INFORMATION

**ALENZA Peel** is a spray adjuvant for industrial and aquatic herbicides. **ALENZA Peel** ingredients are specially selected from by-products from the citrus industry and improve wetting, penetrating and activation of herbicides in broadleaf and wood-plant species.

### FIRST AID

**Call a poison control center or doctor immediately for treatment advice.**

**If Swallowed:** Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.

**If on Skin or Clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes.

**If Inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible.

**If in Eyes:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses if present, after the first 5 minutes, then continue rinsing eye. Have the product container with you when calling a poison control center or doctor, or going for treatment.

<u>Type of Application</u>	<u>Per 100 gallons</u>
Rights-of-Way:	1 Pt - 2 Qts
Forest Site Preparation:	1 Pt - 2 Qts
Aquatic - Surface:	1 Pt - 2 Qts
Submerged:	1-2 Gallons

**Note:** Variations in weather and application types may cause needed rates of **ALENZA Peel** to increase or decrease. The selectivity of herbicides in conifer release is affected by **ALENZA Peel**. Do not use in concentrations of 15% or more, as burning and defoliation of vegetation may occur. **ALENZA Peel** should only be used when recommended by the manufacturer or where proper testing and/or experience allows.

### STORAGE AND DISPOSAL

Store at temperatures below 120°F. Product may expand slightly in storage causing slight pressure to build in container. Avoid temperature extremes. Triple rinse container into the spray solution and discard or offer for recycling or reconditioning. Always dispose of containers according to Federal, State and Local guidelines.
